

ISSS Link Re-Naming Contest

ISSS is re-naming ISSS Link, and we are looking for ideas from current international students on what to re-name the student portal.

How Do I Enter?

Between December 3, 2021 and February 14, 2022, submit your idea for re-naming ISSS Link using the form [here](#). On February 28, 2022 three (3) winners will be selected to win 1st prize AirPods, 2nd prize Fujifilm Camera and 3rd prize JBL speaker. All entries must include the date the form was submitted, must be in English, must be no longer than 10 characters, must not include numbers, and must include the entrant's Emory university ID, the entrant's name and the entrant's email to be entered to win.

All entries must be received by 11:59 PM EST on February 14, 2022. Entries submitted after 11:59 PM on February 14, 2022 will not be included in the contest.

Official Contest Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. **Eligibility:** The Contest is open only to those who are 18 years of age or older as of the date of entry. The Contest is only open to current international undergraduate and graduate students of Emory University and Oxford campus as well as scholars on J-1, H-1B, E-1, O-1, TN visas and is void where prohibited by law. The Contest is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.
2. **Agreement to Rules:** By participating in the Contest, the contestant ("You") agrees to be fully and unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decision of Emory as final and binding as it relates to the content of the Contest.
3. **Contest Period:** Entries will be accepted online starting on December 3, 2021 at 12:01 AM EST and ending February 14, 2022 at 11:59 PM ("Entry Period"). No submissions will be accepted after the deadline for any reason. The sole determinant of time for the purposes of the Contest will be Emory located in the Eastern Standard Time (EST) zone. Entrants entering close to the posted deadline do so with this information in mind.
4. **How to Enter:** The Contest must be entered by submitting an entry using the form [here](#). The entry must fulfill all Contest requirements to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Emory. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Emory.

5. No Purchase Necessary: A PURCHASE OF ANY PRODUCT OR SERVICE IS NOT REQUIRED TO ENTER THE CONTEST.
6. Prizes: The Winner(s) of the Contest (the "Winner(s)") will receive 1st prize AirPods, 2nd prize Fujifilm Camera, and 3rd prize JBL speaker. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of Winner(s). No substitution of the prize or transfer/assignment of prize to others or request for the cash equivalent by Winner(s) is permitted. Acceptance of prize constitutes permission for Emory University to use Winner's(s') name, likeness, and entry for purposes of advertising and trade without further compensation unless prohibited by law.
7. Odds: The odds of winning depend on quality of eligible entries.
8. Winner Selection and Notification: Winner(s) will be selected under the supervision of Emory University based on the unique quality of the entry. Winner(s) will be contacted via email within a week of Contest completion. Emory University shall have no liability for Winner's(s') failure to receive notices due to spam, junk e-mail or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. If Winner(s) cannot be contacted, is ineligible, fails to claim the prize within fifteen (15) days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize is void. The prize offered in the Contest is conditioned upon compliance with any and all federal, state, and local laws and regulations. ANY VIOLATION OF THESE OFFICIAL RULES BY WINNER(S) (AT EMORY'S SOLE DISCRETION) WILL RESULT IN WINNER'S(S') DISQUALIFICATION AS WINNER(S) OF THE CONTEST, AND ALL PRIVILEGES AS WINNER(S) WILL BE IMMEDIATELY TERMINATED.
9. Rights Granted by You: By entering the Contest, You understand and agree that Emory shall be the owner of all, right, title, and interest in and to your entry, and that, by submitting your entry, you are assigning all such right, title, and interest to Emory. You acknowledge and agree to execute and return to Emory any documentation prepared by Emory that is reasonably necessary to confirm Emory's ownership of your entry. By entering the Contest, you further understand and agree that Emory, anyone acting on behalf of Emory University, and Emory's licensees, successors, and assigns, shall have the right, where permitted by law, to print, publish, broadcast, distribute, and use in any media now known or hereafter developed, in perpetuity and throughout the World, without limitation, your entry, name, portrait, picture, voice, likeness, image, statements about the Contest, and biographical information for news, publicity, information, trade, advertising, public relations, and promotional purposes, without any further compensation, notice, review, or consent. By entering the Contest, You represent and warrant that your entry is an original work of authorship, and does not violate any third party's proprietary or intellectual property rights. If your entry infringes upon the intellectual property right of another, Emory may, in its sole discretion, and without waiver of its other legal rights and remedies, disqualify You from the Contest. If the content of your entry is claimed to constitute infringement of any proprietary or intellectual proprietary rights of any third party, You shall, at your sole expense, defend or settle against such claims. You shall indemnify, defend, and hold harmless Emory

University from and against any suit, proceeding, claims, liability, loss, damage, costs or expense, which Emory University may incur, suffer, or be required to pay arising out of such infringement or suspected infringement of any third party's right.

10. **Terms & Conditions:** Emory reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Contest should virus, bug, non-authorized human intervention, fraud, or other cause beyond Emory's control corrupt or affect the administration, security, fairness, or proper conduct of the Contest. In such case, Emory may select the Winner(s) from all eligible entries received prior to and/or after (if appropriate) the action taken by Emory. Emory reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Contest or website or violates these Terms & Conditions. Emory has the right, in its sole discretion, to maintain the integrity of the Contest, to void votes for any reason, including, but not limited to: multiple entries from same computer in excess of that allowed by Contest rules; or the use of bots, macros, scripts, or other technical means for entering. Any attempt by an entrant to deliberately damage any website or undermine the legitimate operation of the Contest may be a violation of criminal and civil laws. Should such attempt be made, Emory University reserves the right to seek damages to the fullest extent permitted by law. Emory University's failure to enforce any terms of these Official Rules shall not constitute a waiver of that provision. All taxes on prizes, if any, are the sole responsibility of each Winner.
11. **Limitation of Liability:** By entering, You agree to release and hold harmless Emory University and its subsidiaries, affiliates, partners, representatives, agents, successors, assigns, employees, officers, and directors from any liability, illness, injury, death, loss, litigation, claim, or damage that may occur, directly or indirectly, whether caused by negligence or not, from: (i) such entrant's participation in the Contest and/or his/her acceptance, possession, use, or misuse of any prize or any portion thereof; (ii) technical failures of any kind, including but not limited to the malfunction of any computer, cable, network, hardware, or software, or other mechanical equipment; (iii) the unavailability or inaccessibility of any transmissions, telephone, or Internet service; (iv) unauthorized human intervention in any part of the entry process or the Contest; (v) electronic or human error in the administration of the Contest or the processing of entries.
12. **Disputes:** This Contest is governed by the laws of the United States of America and the state of Georgia, without respect to conflict of law doctrines. As a condition of participating in this Contest, You agree that any and all disputes that cannot be resolved between the parties, and causes of action arising out of or connected with this Contest, shall be resolved individually, without resort to any form of class action, exclusively before a court located in the state of Georgia having jurisdiction. Further, in any such dispute, under no circumstances shall You be permitted to obtain awards for, and hereby waives all rights to, punitive, incidental, or consequential damages, including reasonable attorney's fees, other than Your actual out-of-pocket expenses (i.e. costs associated with entering this Contest). You further waive all rights to have damages multiplied or increased.
13. **The Contest is hosted by Emory University's Office of International Student and Scholar Services.**

14. By submitting your entry, You have affirmatively reviewed, accepted, and agreed to all of the Official Rules and have certified You are eligible to participate in the Contest.
